September 11, 2024

- I. Call to Order: The meeting was called to order at 7:00 P.M. by Trustee Shepard.
- II. The Pledge of Allegiance: Trustee Shepard led the Pledge of Allegiance.
- **III. Roll Call:** Roll call indicated the following Trustees were present: Goeckner, Turner, Shepard, and Smouse. Also present was Clerk Dyer Dawe. Supervisor Shaughnessy was absent.

IV. Citizen Comments: None.

V. Minutes:

 The minutes of the August 14, 2024 Antioch Township Regular Board Meeting were presented. Motion to approve the minutes as presented was made by Trustee Smouse, seconded by Trustee Turner. Motion carried with a roll call vote. Yes: 4 – Shepard, Smouse, Goeckner, Turner, No: 0.

VI. Treasurer's Report:

- Township bills were presented for payment in the amount of \$111,447.90. Motion for payment as presented was made by Trustee Turner, seconded by Trustee Goeckner. Trustee Goeckner inquired if the epoxy floor charge was for the new building and what percentage of budget has been spent on Boeller for Thelen Park. Motion carried with a roll call vote. Yes: 4 – Goeckner, Turner, Shepard, Smouse, No: 0.
- Road District bills were presented for payment in the amount of \$98,258.38. Motion for payment as presented was made by Trustee Turner, seconded by Trustee Smouse. Motion carried with a roll call vote. Yes: 4 Smouse, Shepard, Turner, Goeckner, No: 0.

1. Supervisor:

- Trustee Shepard shared the elected official compensation resolution was updated to reflect no extra compensation for trustees. It will be voted on next month. The compensation has to be a set amount for the position and can't be variable. Trustee Goeckner noted he did not have a problem with it, but how the Township could make sure it wasn't abused. Trustee Turner shared as good as the intention was, it is unknown what future boards could do with it.
